



STRATEGIES TO EMBED A SCHOOL CULTURE OF CHILD SAFETY

Rationale:

This document sets out the strategies that Goornong Primary School will implement to embed a culture of child safety.

Responsibility:

It is school council's responsibility to review and approve the school's response to meeting the Child Safe Standards. The school principal is the school's Child Safety Officer and has the responsibility of ensuring the policies and practices approved by school council are implemented effectively. All school staff and members of the school community have responsibility for acting in accordance with the policies and practices and to promote a child-safe environment within the school.
